



RULES & REGULATIONS TO ENSURE EVERYONE HAS A GOOD TIME

1. Membership shall be open to all families, couples and single people who have declared their belief in, and wish to practice Naturism for health and recreation.
2. Single people will be admitted as vacancies occur but will be required to supply satisfactory character references.
3. New members are permitted to wear clothing on their first visit if they so desire.
4. Termination of membership without explanation or refund of fees remains the reserved right of the Executive Committee.
5. All fees become payable upon being accepted for membership and thereafter in advance prior to the start of each Club financial year.
6. Privacy of membership will be respected at all times, members will be known to each other by First names only, no member may publish the name of any other member nor make any statement or disclosure in the name of the Club to the media without the express approval of the Executive Committee.
7. Cameras are not permitted on Club grounds unless especially authorised by the Executive Committee and no photographs may be displayed or reproduced under any circumstances without the full approval of all members concerned.
8. Club grounds lay within private property but members must remain inside the defined Club boundaries and may not climb rocks forming part of the perimeter.
9. Access to the Club is by road only and entry must be by vehicle and not on foot.
10. Visitors are only allowed with the prior permission of the Executive Committee.
11. Trees, shrub and plants shall not be cut down or removed from the grounds except with the Executive Committee's approval.
12. Pets cannot be permitted in the grounds under any circumstances.
13. Care and maintenance of the grounds and equipment are normally done by the members to maintain a low level of Club fees and to this end all members will be expected to assist from time to time in the work.
14. Campers are required to keep their sites clean and tidy and the owners of the cabins and caravans are responsible for ensuring these are kept in good order and repair and the surrounding area well maintained.
15. Rules and regulations may be formulated or amended from time to time to ensure the orderly operation of the Club by the Executive Committee or its Office Bearers and must be complied with by all members.
16. Alcohol is only permitted in the clubhouse with meals, BBQ area with meals and in the privacy of their own areas. No alcohol is allowed on the lawns or car park area.
17. Members who have vans sites are entitled to the privacy of their own areas. No-one is allowed on those sites unless invited by the van site lessee.
18. Only non-greasy sun lotion is to be used, everyone must shower before using the pool to remove excess sun lotion, perspiration etc.
19. Parents are required to be attentive to their children, vigilant to their safety, especially in the pool, and be responsible to the general Club welfare. They are your children, we welcome their visit, but we don't want to see them get hurt! A parent MUST be with any under-teen child within the pool area, this responsibility may NOT be delegated. All children that are unable to swim must wear a recognised safety floatation device.
20. No food or drink is permitted within the pool area.
21. Clothing in any form is not accepted in the pool itself and the sauna.
22. If, at any time, you feel uncomfortable by any inappropriate remarks or behaviour by any member or visitor, please discuss the issue immediately with a Committee Member.
23. Do not discard cigarette butts around the grounds.
24. Do not light fires, other than the BBQ or showers.
25. Members are requested to take their garbage home.
26. Members are requested to park their cars in the parking areas only. The Executive Committee has the right - at all times - to tell members where and where not to park.
27. Return all equipment - tools, sports equipment, chairs etc. - to their storage space after use.

Conditions of membership

It shall be accepted that those persons whose signature appear on the membership application agree on their own behalf and on behalf of those children, if any, whose names are shown here, to abide by the rules and regulations as exist or as are formulated or amended from time to time and further agreed not to attach responsibility of any kind to the Naturi Sun Club, its management, or any of its members, for any injury, loss or damage to person or property arising from membership, should this application be accepted.
